Frank Beaton was a Hudson's Bay Company factor and a mining recorder in Fort St. John, B.C. Records include diaries, account books, letter books [reports], papers relating to service with Hudson's Bay Company in British Columbia 1883-1928, record of placer claims, Peace River District 1916-1936 under British Columbia Placer Mining Act 1891, sundry mining receipts, correspondence, receipts, documents concerning his sons, and clippings, 1927-1943.
