DETECTIVE SCALLION,

called as a witness, being first sworm, testified as follows:

QUESTIONS BY MR KENNEDY:

- 1 Q You are a Detective in the city of Vancouver, and were such at the time this occurred.?
 - A Yes.
- 2 Q As a detective, you are also a peace officer.?
 - A Yes.
- 3 Q I want you to tell His Worship about this case.?
 - A On Sunday the 16th day of Ausgust, Your Honour, Lee Coy came to my house and brought this envelope containing eighty dollars.
- 4 Q How was it brought.?
 - A It was sealed in an envelope.
- 5 Q Have you got the envelope.?
 - A Yes.
- 6 Q Have you the money.?
 - A Yes.

- 7 Q Is this the way you received the money ??
 - A Yes.
- 8 Q It has a one cent stamp on it not cancelled .?
 - A It was sealed.
- 9 Q Who opened it.?
 - A I opened it.
- 10 Q Had you had a talek talk with Lee Coy previously to that.?
 - Yes, I did, about three days previous; Sunday. I think it was on a Wednesday Lee Coy came to my house half past eight in the morning and asked me, he wanted me to let him open up a gambling) joint at 513 Carrall Street and Is aid No. Isaid "Any time you want to see me, come down to the office, don't come to my house, don't come back here again." A few days previous to this he telephoned to my house on two different occasions wanting to see me. I told him he could see me here but he never came until he came to the house a few days later. It was on August 21st.



- 11 Q When he telephoned, did you speak to him personally.?
 - A On one ocasion I did. On August 21st he was in the police court after he gave me this money; I was looking for him.
- 12 Q On what date did he bring the money to your house.?

- 7 9 Had you had any conversation with him before.?
 - A On the night of the 14th, that would be Friday of August, a party and myself met this man in chinatown and he asked when he could see us together. We told him he could see us at the Police Head-quarters at two o'clock in the afternoon Saturday or eight o'clock in the evening. He came up here two 6Ldlock Saturday after noon the 15th and waited outside. A little after two Detective Scallion and myself were leaving the place and he was waiting outside and he came up and spoke to me. Detective Scallion walked ahead a little bit, a couple of paces, and he asked me if it was all right; I said "what's all right"; "oh" he said,



he asked me if tit was all right and I asked him what he meant, what he was talking about; he said "your partner no tell you" Then he took a note book out of his pocket and wrote in the inside of the note book along the top of the page, eighty, forty dollars you and forty dollars for him, he said "you tell him " I said "All right I will tell him" and he walked off. The next I heard about it was Sunday night when Detective Scallion 'phoned me.

QUESTIONS BY MR GRANT:

- 108 Q That is all the conversation you had with him outside the police station on the 14th.?
 - A On the 15th yes, it lasted only a short time while walking from the door to the corner of the lane.
- 9 Q Did you tell him to pay the money to Mr Scallion.?
 - A I certainly did not. I did not tell him to pay any money at

- 1 Q Who arranges for the raids on these various places in Chinatown, do you ger your instructions from Headwuarters.?
 - A We come to head quarters for our instructions but as a rale we arrange them as we go along.
- 2 Q You have to wait for instructions.?
 - Ag From Headquarters sometimes it is a little difficult to find them, they may be a little bit busy, it may be put off for a day or two so.
- MR KENNEDY: That is the case for preliminary Hearing, Your Worship.
- MR GRANT: I have arranged with My Friend that the actual committalwill not take place until tomorrow.



 - 9 Q During the last three months you cannot tell me of more than two places that have been pulled.


