- 1 Q Wers do you live? A. At Extension.
- 2 9 Where were you at the time of the trouble down at Extension Did you stop at Extension? A. Yes.
- 3 Q In whose house did you live there? A, With my brother Dominio.
- 4 Q Did you brother Ecminic loss anything? A. Sure, he loss everything.
- 5 Q Have you found any of it since? A. I have got something over there.
- MR SHOEBOTHAM; -just show him those trousers.
- 6 Q Whose trousers are those? A. phose are my brother Dominic's.

TROUSERS MARKED EXHIBIT 1

7 Q And to whom does this belong? A. My brother; it is broke there.

ACCORDEON MARKED EXHIBIT 2

- S Q When did your brother leave? A. When they started the trouble.
- 9 Q About what date? A. When they started the trouble. I was the last man there.

 A Wednesday.

- 12 Q Your brother went away and has not come back since?

- 78 Q Was there anything else lost? A. I guess that is about all that was found. I don't know just what they did take out of the house.
- 79 Q whe articles you have identified, you have no doubt about? A No, we lost some bedding that never was found.

CROSS EXAMINATION;

BY MR LEIGHTON; -

- 80 Q You know nothing about how these things arrived here or where they have been since you saw them last in the house?
 - A I just saw them last in the house. I saw them picked out of the wood pile at John Harkel's.
- Sl Q Just describe that wood pile? A. It was in his back yard.
- 82 Q Is the yard fenced? A. Yes, a picket fence that he made

himself.

- 83 Q Is it fenced all round? A. Pretty near.
- 84 Q What do you mean by that, are the four sides fenced? A.Yes.
- 85 Q Did you ase those things in the wood pile? A. I was standing there when they took them out.
- 86 0 How near the house? A. Well it was just at the back door.
- 87 Q Were they covered with wood? A. Yes.
- 35 Q was the accused around there at the time? A. No.
- 89 Q Do you know Mr Harkel at all? A. Yes.
- 90 Q Do you know where he was on the 13th and 14th and 15th?
 A I guess he was in Extension.
- 91 Q You didn't see him? A. Yes, I saw him on the 13th and the 15th.

(Witness aside)

JAMES WHITE

SWORN

EXAMINED BY MR SHOEBOTHAM; -

- 92 Q Where do you reside? A. Extension.
- 93 Q Do you remember the troublous times last month? A. Yes.
- 94 Q And as a result of those troubles were you a loser in any way?

 A. Yes, I lost almost everything I had out of the house.
- 95 Q In what way did you lose it, did you dispose of it in any way?

 A No sir, I suppose somebody took it; they were taken away

 from the house.
- 96 Q Have you been able to recover any of it? A. A few articles have been.
- 97 Q wave you seen them? A. Yes.
- 98 Q Would you be able to identify those articles again if you saw them! A. Yes.
- MR SHOEBOTHA?; You might just produce Mr White's articles.
 - A. That boiler belongs to me and that matting is mine and the oil cloth is mine. It is just exactly the same kind of stuff that we had. We had a room finished with this.
- 99 Q Was it taken off the walls? A. Yes.
- 100 Q Would you recognize any garment of your wife's? A. That coat is hers;
- 101 Q Would you be able to recognize any articles belonging to Janasia? A. Well, there are lots of things I think I would, some things perhaps that I have seen there.
- 102 Q By the way, were you present when those things were discovered A Yes.
- 103 Q When was it that they were discovered; do you remember the day on which you saw the articles, when they were discovered? A. I don't believe I do remember the day they were discovered, the exact day.

- 104 Q (By the Court) Were you present? A. Yes, I found some of them myself, I was in the search party.
- 105 Q (By Mr Shoebotham) Where were they found? A. The boiler
 I found myself at a stimp very close to Mr Harkel's house,
 shout two yards, and some other things. I was there
 when the straw matting was found under his wood pile in the
 wood house.
- 106 Q How far from his wood house to his house? A. It would not be more than ten feet between them.
- 107 Q Will you just describe the wood pile? A. Well, Mr Harkel has quite a wood pile in his wood house and he has got it around three sides, built up four or five feet in height. One tier of stove wood, 14 or 16 inches long and inside of the vacant space just something like this witness box, this stuff was laid on the ground and the wood piled in on top of it.
- 105 Q Was there any other stuff? A. Yes. I found the accordeon mxxxixxe and a blue pair of pants.
- 109 Q Anything else? A. Flat irons and boots were found in his hen house; there is two or three feet between that and the wood house. I found the spring and child's cot and a lot of stuff which looked as if it was hid at the corner of the wood house.
- 110 Q was there anything clee found under the wood pile, up on
 Mr Harkel's premises? A. I think that is about the lot
 under the wood pile. We found quite a lot of stuff
 around the garden and fence, a big trunk and a lot of cooking
 utensils.
- 111 Q Would you recognize that trunk if you saw it? A. Yes.
- 112 Q Just take a look at that trunk over there? A. The trunk has one leather handle torn off it; that is the trunk we found.

- 113 Q That also was found in Mr Harkel's garden? A. Yes, in the corner of the garden under some brush, and a lot of granite ware in it. I looked in the trunk when I found it.
- 114 Q Just look at it now? A. Yes, that is the same stuff.

 The trunk was under a little tree and was covered up with little trees cut and shoved over.
- 115 Q was it visible at a casual glance? A. Yes, you could see it if you walked close past.
- 116 Q But from the street could you see it? A. No sir.
- 117 Q Who accompanied you at that time? A. Some special policemen and Frank Beban and mywife and Mrs Cosier.
- 118 Q Did you ever see that small mattress? A. I didn't see that before it was found.
- 119 Q Did you see it after it was found? A. Yes, but I didn't see that until after it was found.
- 120 Q I don't care whether before or after, where was it? A. I seen it in the place where the Police stop at Extension.
- 121 Q You didn't see it on Harkel's premises? A. No, not that mattress, but the springs I did, when Mr Beban found it in the chicken house along with two policemen.
- 122 Q Do you know the remises to be those of Mr Harkel? A. I know it is where Mr Harkel lives. I live next door to him myself.
- 123 Q Outside of the articles that have been identified did you lose any other articles? A. Yos, a great number of others.
- 124 Q Yours was one of the premises fired and looted? A. Yes, we lost all we had of any value.

CROSS EXAMINATION

BY MRLEIGHTON; -

- 125 Q Do you say that these articles which you have identified as being found on Harkel's premises were your property?

 A Yes, those things I looked at first.
- 126 C the things Mrs White identified? A. Yes.
- 127 Q And these other articles that you have referred to, were found where you described? A. Yes.
- 125 Q You say the trunk was found in the corner of the fence?
 A Very close to the corner.
- 129 Q Near the house? A. There is a little garden; it is no distance from the house, a few yards.
- 130 Q Is the whole lot femced? A. No sir, the garden is femced separate by itself and a walk between it and the house.
- 131 Q The garden is fenced off from the house? A. Yes, the fence doesn't go around the house.
- A Not inside the garden fence, the garden fence? where they were found, a few feet steps from the house.
- 133 Q In that case, they were not inside the fence of his property? A. No, not the trunk.
- 134 Q How near is his house to the next house to it? A. Oh, perhaps 35 or 40 yerds; Jenasia's house on one side and my house on the other side.
- 135 Q Janasia's house from where some of things were said to have been stolen, was just on one side of the accused's house? A. Yes.
- 136 Q Did you see any of the destruction or looting going on at all at Extension? A. Yes, a lot of it.

- 137 Q At that time things were scattered all over the place, thrown out of the houses, were they not? A. I seen stuff thrown out; that was out of Passerini's store; there was lots of stuff taken out of houses; I saw lots of stuff taken out of houses myself but I didn't know the parties who was taking it. I saw a great del of stuff taken out of Mr Fontana's house.
- 135 0 Do you know Harkel? A. Yes.
- 139 C How long have you known him? A. More than 12 months.
- 140 Q Have you been good neighbors, a friendly feeling between you? A. Yee, never had any trouble or words between us.
- 141 Q Did you see stuff taken out or thrown out of Janasia's house?
 A No.
- 142 o You didn't see any destruction going on there? A. No.
- 143 9 Or looting? A. No, I didn't see anything going on at that house. I seen a big mob around it the day of the riot.
- 144 Q Did you see warkel at that time? A. Not at that house.
- 145 0 Did you see him at that time at all? A. Yes.
- 146 Q Was he near his own house? A. No, he was at Fontana's house the day of the riot, the evening.
- 147 Q I mean at the time when the crowd was around Janesia's house? A. He was then at Fontana's place . I saw him going to Wargos'.

RE-EXAMINATION:

BY MR SHOEBOTHAM; -

- 148 Q You say you saw him at Fontana's house? A. Yes.
- 149 Q And was stuff being carried sway from Fontana's house?
 A Yes, on the 14th.
- 150 Q You say there was a crowd around Janasia's house? A. Yes.

- 151 Q was that before or after it was looted? A. It would be before; it was on the 13th, the night of the riot when so many people was in Extension.
- 152 Q You don't know exactly when Janacia's house was looted?
 A No.

- 154 Q When did you next see him? A. On the 14th. I saw himaround with the crowd on the 14th.
- 155 Q Did you over see him in his wood shed; about that time?

 A No, I didn't see him in his wood shed then; I saw him

 wood in his wood shed and piling it in his wood shed; some

- 156 Q You are a special constable? A. Yes.
- 157 Q I believe you had a scarch warrant entrusted to you or some member of the special police? A. Yes.
- 158 Q Mankage To search the premises of John Harkel? A. Yes-
- 159 Q Did you make a search? A. Yes.
- 160 (Who accompanied you on that search? A. Special Constable Elder, James White and a few others who didn't take part inside the premises.
- 161 Q You made your search? A. Yes.
- 162 0 Did you discover anything in your search? A. Yes.
- 163 C Where did you discover it? A. Behind the door as you go into the room.
- 164 Q How many places did you search there? A. Two in particular.
- 165 Q You say you found something bonin the door? A. Yes.
- 166 Q What was it? A. bundle of socks.
- 167 C They have not been identified. We make no claim on those socks. Did you search any other place than behind the door?
- ME LEIGHTON; I object.
- 168 Q Pid you search any other place? A. Other premiseo?
- 169 Q Are you sure that it was Mr Harkel's premises that you searched; I am asking in connection with a search made of Mr Harkel's premises? A. In regard to the names, I should like to have the location of the house explained.
- 170 9 Did you make a search in the wood shed? A. No.
- 171 Q You didn't search Mr warkel's premises at all? A. Possibly I didn't. The first premises that were searched, I

was told to go further on over the hill, I think to Mr Wargos.

THE COURT; - Where is your search warrant?

A. I didn't have the search warrant.

MR SHOEBOTHAM; - Here it is. It was not given to him. That will do.

- 272 Q What is your occupation? A. Special constable.
- 173 Q wave you done any duty in or about Extension at all? A.Yes.
- 174 Q Did you assist is exsouting any search warrant down there?
 A Yes; Harkel's and Wargos'.
- 175 C In searching Harkel's premises what did you discover, did you discover any goods? A. Yes, I discovered a box.
- 176 Q What do you mean by box? A. Traveling trunk.
- 177 C Did you examine it at the time? A. Yes.
- 178 Q Do you think you could tell it again? A. Yes.
- 179 Q You might go and examine that trunk there? A. Yes, that is the trunk (Exhibit 3)
- 130 Q Did you open it at the time? A. Yes. When we brought it in to the back door we opened it.
- 181 0 What did it contain? A. A lot of kitchen utensils.
- 182 C And did you make any further search there? A. No, I was
 put out on the bill after that to watch other houses
 that we were going to search so that they would not get
 a chance to threw stuff outside.

- 195 Q What is your occupation? A. Secial police.
- 196 Q At Extension? A. Yes.
- 197 Q Do you know the names of the places where search warrants were executed? A. I know some of them, I can't recollect all of them.
- 198 Q Do you remember Mr Harkel's ? A. Yea.
- 199 O Were you present at the time his premises were searched?
 A yea.
- 200 C Were you precent when any goods were discovered? A. Yes.
- 202 Q Where was this fire wood? A. In the saed.
- 203 Q How far was the shed from the back door of the house? A. I should say about 12 or 15 feet, rough guess.
- 204 Q was there much wood in the shed? A. Yes, a great quantity of newly cut wood.
- 205 Q Just give me a general description of the articles found there? A. There was an accordeon, wrapped up in a blue pair of pants and a pair of boots, a pair of gum boots and two pair of other boots and stockings and mattress underneath the flooring of the shed.
- 206 Q Did you examine the mattressa A. Yes.
- 207 Q Would you be able to recognize it? A. Yes.
- 208 Q Just go and see? A. That is it (Exhibit 3)
- 209 Q Did you see a trunk? A. Yes, the trunk was brought from the bush adjoining, about five yards from the house.

- 210 Q Did you examine the trunk? A. Yes, and the contents.
- 211 Q Just see if that is the trunk? A. Yes (Exhibit 3)
 A lot of kitchen utensils inside.
- 212 Q Now from where that trunk was found, what distance was it to the nearest other residence on that side of the house? A.

 Some considerable distance, I should say at least 30 yards or more to my recollection.
- 213 Q Now about how much wood would be on the top of those things?

 Did you find a ny other articles besides what you have
 described? A. Not on the immediate premises; the things I
 saw myself found, the mattress, accorden, pair of blue
 trougers and stockings and boots.
- 214 Q You say you found that mattress? A. I saw it pulled out from under an adjoining outhouse belonging to Mr Harkel's premises.
- 215 Q Outside of those articles do you know of any others that were found? A. That is all I can recollect, some sad irons, 4 irons. and -
- 216 Q These articles that you have described, that were found ubder the wood, you have told us what they were? A. Yes.
- 217 Q Did you examine the accordeon closely? A. Yes, I could tell it.
- 218 Q Just see if you have ever seen this before? A. Yes, this is the accordeon and those are the trousers. Those were at the back, not exactly underneath but wood planked up against it.
- 219 Q was it visible to the naked eye? A. No.
- 220 Q Who was present when you unearthed the spoil from underneath the wood pile? A. _he other constable was present and Frank Beban and Mr White.

CROSS EXAMINATION

- BY MR LEIGHTON; -
- 221 Q This shed you speak, of, what sort of shed is it?

 A An ordinary wood out-house, open in front, no doors on it.
- 222 Q Did you search the house? /. Yes.
- 223 Q And you found nothing in the house? A. No.
- 224 Q These goods you found just scattered around in any place where they could be thrown? A. They were hidden.
- 1 saw them brought in from around the bush close by.
- 26 Q What other things? A. A trunk containing a lot of culinary utensils and roll of matting and a coat and chair.
- 227 Q was there anything found in the bush in the vicinity. I understand that Janacia lost a lot of stuff; was any other of his stuff found in the vicinity? A. I don't know of snything slee.
- 223 C Was any stuff found around Janasia's thrown out? A. I was not there.
- 229 Q He is the next door house? A. I didn't go there.
- 230 Q You didn't notice whether there was stuff thrown out around his house? A. No, I was only scarching Harkel's premises then.
- 231 Q Near many houses that were destroyed, the stuff was thrown out, scattered about, was it not, after the looting?

 A Not in this vicinity, I didn't see any.
- 232 Q You didn't see the place until about the 19th? A. I was there before that.

235 Q Were you around there previous to that? A. No, after. 234 G How long after? A. On the 19th and afterwards.

MR SHOEBOTHAM; - what is the case Your Worship.

MR LEIGHTON; - No defines to call now.

THE COURT; (To the Accused)

Having heard the evidence, do you wish to say anything in answer to the charge? You are not obliged to say anything unless you desire to do so, but whatever you say will be taken down in writing and may be given in evidence against you at your trial.

You must clearly understand that you have nothing to hope from any promise of favour and nothing to fear from any threat, which may have been helt out to you to induce you to make any admission or confession of guilt, but whatever you now say may be given in evidence against you upon your trial, notwithstanding such promise or threat.

MR LEIGHTON; - Nothing to say.

THE COURT; - There is sufficient evidence to go to a jury.

Twill commit you to the common gaol of manaimo to await

your trial at the first Court of Competent Jurisdiction.
