County of Yale, in the Province of British Columbia, on the twenty-first day of October, in the year of our Lord one thousand time hundred and three, one Chung Fook unlawfully did wound with intent in so doing to him the said Chung Fook to do some grievous bodily harm, against the form of the statute in such case made and provided, and against the peace of our said Lord the King, his crown and dignity:

- 2. And the jurors aforesaid do further present that the said Lo Sue, afterwards to wit, on the day and year and at the place last aforesaid, at and against one Ah Bow, a loaded firearm, to wit, a revolver, unlawfully did shoot with intent thereby then unlawfully the said Ah Bow to kill and murder, against the form of the statute in such case made and provided, and against the peace of oursaid Lord the King, his Grown and dignity.
- 3. And the jurors aforesaid do further present that the said Lo Sue, afterwards, to wit, on the day and year and at the place last aforesaid, at and against the said Ah Bow a loaded firearm, to wit a revolver, unlawfully did shoot, with intent thereby then unlawfully to the said Ah Bow to do some grievous bodily harm, against the form of the statute in such case made and provided, and against the peace of our said Lord the King, his Crown and dignity:

I hereby direct that the counsel for the Crown at the Greenwood Spring assizes, 1904, prefer this Bill of Indictment to the Grand Jury.

Chong Gow: -

and I know the I am a cook for accused. I saw him in Chinatown in this City last Wednesday at about 8:30, p.m. He was on the street near Quon Lung's. We met and said "Hello, how do you do." I was afterwards in Sam Wo's laundry. Sick Foy saidthe accused wanted to see me, and I said I did not want to go. He said he wished me to go. Sick Foy and I went into Chung Fook's store. I saw Chung Fook's face covered with blood. I asked what was the matter and was told. Low Foon was helping Chung Fook fix his head inside the store by the table. Hook Chong held a lamp for them to see. About ten minutes afterwards the accused came in and he, the accused, was holding one hand(left hand)to his nose and one hand in his pocket. I said "Sue, what is the matter? Make no troubie." He said some one foosed him. I said nobody footed him. He tooked att around. Sue said "Chong, I want to speak to yo u." He walked up and down for about ten feet. I was behind him by the kitchen. He 100ked all around the kitchen. He then turned back. He said nothing to me. I followed him. He looked inside the bedroom off the store, and Ah Bow was lying down on the clothes with a Chinese lamp at one side. He, the accused, looked in and saw Ah Bow. His, the accused's, hand was in his pocket. I thought he was going to fight Ah Bow. He pulled out a gun and shot at Ah Bow. I don't know where he got the gun. He had it in his pocket. He hit the lamp and the grass went all in pieces. He shot a second time and I ran outside. When I got away I heard a third shot. As I reached Quon Lung's place. The accused did not speak. I did not see the pistol. I was behind the accused.

I am a Chinese merchant and I know the accused Lo Sue. I saw him on Wednesday last (21st instant) at about eight o'clock in the evening at my house or store in this City. That evening Low Foon was in my store. The accused claimed that Low Foon owed him \$8.00 in Victoria eight years ago. I paid the \$8. to Hop John who paid Lo Sue for Low Foon about 4 o'clock that day and Lo Sue went home to cook dinner. At night time, eight o'clock, Lo Sue came again to my house and he told Low Foon that I paid him \$8., and Low Foon said that was all right. The accused swore a little bit and Ah Bow said to keep quiet -told Lo Sue. The accused did not want Ah Bow to talk, and the accused got mad a little bit and swore, and he wanted to fight Ah Bow in the house. I put them out as I did not want them to fight in my house, and accused cut my head a little bit -- not much. Low Foon put medicine on my head. Ah Bow was in the room and lay down on the bed and the accused shot at him.

Cross examined:-

The room was my bedroom in the store. Lo Sue was fighting Ah Bow, and I was cut a little bit. Lo Sue was not fighting or swearing at us. I saw the knife Lo Sue used. It was five or six inches long. Sue had the knife. He hit me a little bit. He did not want to hit me. I was pulling him out. I paid Hook Ping the \$8. and he paid Lo Sue. I did not see him pay. I don't know how the accused hurth his nose.

Re-examined:

When the accused came to my house in the evening, Ah Bow, Low Foon and I were in my bedroom. Lo Sue told Ah Foon he received the \$8. Low Foon said that

was all right. Ah Bow talked to Lo Sue and Lo Sue swore a little bit. I put Lo Sue into the store and Ah Bow remained in the room. When I was putting Lo Sue out I got cut a little bit by a knife. 

Chung Fook: -



The accused swore a little bit and Ah Bow said to keep quiet -told Lo Sue. The accused did not want Ah Bow to talk, and the accused got mad a little bit and swore, and he wanted to fight Ah Bow in the house. I put them out as I did not want them to fight in my house, and accused cut my head a little bit -- not much. Low Foon put medicine on my head.
