they told me to wipe dishes, they went out to kill chickens; the dish washer went first; I went out second, Ah Hing went out last; Ah Hing scolded me at the place where they killed the chickens, in the back yard; Defent. said to me "Toon Muck A High," which is swearing in Chinese; Defendant said he would stab me to death; defendant held out his gand with a knife in it, rolled his eyes, and looked very cross, and I started to run; defent. ran after me; the knife produced is the one that was in defendant's hand; I ran about as fir as I stand to the door of the Court; the defendant caught out to me, and put his hand on my shoulder; one hand he held my shoulder and with the other he stuck the knife in me, after the knife struck me, I fell down; one of the waiters helped me up.

Cross examined by Mr. Hall.

I had been working at the Delmonico for three weeks; I did not know the prisoner before I went there; the defendant was always



scolding me; I was working over a week and two or three days more, when he started scolding me, I have scolded the defendant; I did not scold him very often; we both worked in the kitchen, b but not at the same work; we never foughted together; Ah Hing scolded me for having been too long away with the dinner for the Mrs. Ah Hing told me to kill chickens on the day of the stabbing; I killed one chicken and got it almost cleaned; it took me about ten minutes to do it. The dish washer killed a chicken at the same time; the defendant killed one last; at 1 before the cutting Ah Hing scolded me and I scolded him back; the accused to me: "Toon Muck O' High, and then I waid the same to him; directly after using these words the prisoner raised his hand with a knife in it, looked very angry; I ran away; he ran after me and stabbed me, I left the chicken at the place where it was killed; Ah Hing and another Chinaman were on one side of a box, and I was on the opposite side of that box when we were plucking the chickens; I threw nothing at Ah Hing; I dropped the chicken; I did not hit Ah Hing with anything I do not know that I hat Ah Hing with the Chicken; I just dropped it and ran; I did not put the chicken on Ah Hing's head; Ah Hing was in the habit of scolding me every day, I was not in the habit of scolding back, the other Chinamen used to scold me much; Ah Chue is the name of the dish washer who was with us in he back yard; Ah Chue scolded me, but did nothing in the stabbing business; Ah Chue and Ah Hing both told me that the three Chinamen working in the kitchen were relations; Ah Hing was not very friendly to me; after the first ten days I was at the Delmonico; we did not play together; I didn't "refuse to allow a Dr. to examine me last Friday; I felt pain; the



shirt produced is the one I had on when I was stabbed.

To the Court: I did not see where Ah Hing went after I fell; I was in too much pain to take notice.

I am a Police Constable, I see the knife produced; it was in my posse sion for a short time on Saturday evening, the 17th inst. about 4 p.m. a Mr. Corbett handed it to me; I was in the yard of the Delmonico when the knife produced was handed to me; Corbett picked it up near the back door of the Delmonico Restaurant kitchen, I saw him pick it up; Corbett went in the kitchen first, and went into the back yard first; I handed the knife either over to Con. Iwas in the Restaurant on that afternoon, and saw Ah Wee there; I saw him suffering after he was stabbed with a knife; I saw him, it might have been a minute or a minute and a half after he was stabbed, he was laying in the back yard of his back on the ground; he was crying and making a noise; the prosecutor does not speak English at all; I heard him crying and I went out to see what was the matter; I told him to get up and he did not get up, so I helped him up; I did not notice blood on the ground, but when I lifted him up I saw blood on his shirt; I recognize the knife produced; I have seen it in the kitchen of the Delmonico; I saw the knife produced after the stabbing affray; I saw it laying on the ground in the back yard about four or five feet from where Ah Wee was lying or perhaps less; ther was blood on it; I picked it up and put it on a box; I have not seen it from that time until now; John Corbett, bartender of the Delmonice saloon, was there shortly after I was; it may have been five minutes or less; I then went in the restaurant and the steward of the came out with me; about that time three police came in; the defendant was arrested shortly after that.



Cross-examined by Mr. Hall.

I have known Ah Wee about a month; the defendant for about four or five months; they seem to get along spleadedly together, I say spleadedly because never saw any quarreling; I was about half my time in the kitchen, when I went to the yard, I saw Ah Wee and the accused and a Chinese Dish washer; the knife was being used on that day I think for cleaning chickens; Ah Wee washed dishes, the defendant acting as second cook at that time.

To the Court: The ary that drew me out to the back yard appeared to be of a boy suffering pain.
