
THE KING against QUONG and WONG JOE

The Fifth day of June, A.D.1909, at the City of Vancouver and the County of Vancouver before William Wallace Bruce MeInnes, Esquire, Senior County Judge of the County of Vancouver, exercising criminal jurisdiction under the Provision of Part XVIII (18) of the triminal Code relating to the speedy trial of indictable offences. Quong and Wong Jos were committed for trial to the common goal of the said County and stand charged this day before the Judge sitting in open Court, assembled for the trial of the said Quong and Wong Joe, as follows:-

For that they, the said Quong and Wong Joe, on or about the 26th day of May, in the year of our Lord, one thousand nine numared and nine, at the City of Vancouver, in the County of Vancouver aforesaid, did unlawfully steal one bicycle the property of one Charles Goldberg, being over the value of Ten Dollars (\$10.00), against theform of the Statute in such case made and provided and against the peace of our Lord, the King, his Crown and Dignity.

COURT: "Do you consent that the charge against you shall be tried by me, or do you desire that it shall be sent for trial by a jury at the next Court of Oyer & Terminer & General Goal Delivery, to be held at the said City of Vancouver, on or about the month day of October next, as the Lieutenant-Governor in Council may appoint ?"

MR. RUSSELL: Preliminary hearing. CHARLES GOLDBERG CALLED AND SWORNP DIRECT EXAMINATION BY MR. KENNEDY:

1 Q: Your name is Charles Goldberg ? A: Yes.

2 Q: And you live where ? A: Dunlevy Axaxax Apartments.

Q: That is where ? A: Dunlevy Avenue. 3

- 4 Q: Did you have a bicycle on the 26th of May ? A: Yes.
- 5 Q: Look at that bicycle behind you and state if it is the same one ? A: Yes, I had it for three years.

13 Q: And you found it was not there ? A: No:

14 Q: What day of the week would the 26th fall on ? A: It was the 27th I missed it.

MR. KENNEDY: Will you pardon me one moment, Mr. Russell?

- 15 Q: Do you know these two Chinamen ? A: I do not.
- 16 Q: Would they have permission to take your bicycle ? A: They did not.
- 17 Q: MR. RUSSELL: On what day of the week did you say the 26th of May happened to fall ? A: I can not say exactly.
- 18 Q: It was on the 26th that you missed the bicycle ? A: The next day I went to take the bicycle and it was not there.
- 19 Q: What day was the next day, was it Thursday or Friday, on what day of the week ? A: Tuesday I believe it was Tuesday night when I left the bicycle. I can not say for sure.







Q: This key you spoke of as being on ring Exhibit "B", 11 as being a skeleton key is also known as a pass key, is it not ? A: I have never heard of it.

SERGEANT-DETECTIVE JACKSON CALLED AND SWORN:

DIRECT EXAMINATION BY MR. KENNEDY:

- 22 Q: You are a detective in the City of Vancouver ? A: Yes.
- 23 Q: Hadany experience with burglars tools ? A: I have.
- 24 Q: How many years have you been a detective ? A: Nearly ten years.
- Q: I want you to lhok at this pair of shears which are produced as Exhibit "A" and state what in your estimation they are ? A: They would be used for cutting fine wire, screen doors or screen windows or anything that kind. If a fellow wanted to get in a butcher shop at night it would be a handy article to cut the door, or a house where a screen window was.
- 26 Q: What do you consider this article ? A: A burglars tool that is when you find it on a person in the small hours of the night.
- 27 Q: Look at this bunch of keys and say what you have to state about those keys ? A: The majority are ordinary keys with the exception of this key. You could pick almost any door with it except a Yale lock.
- 28 Q: What is it called ? A: I have always called it a skeleton key.
- 29 Q: Look at Exhibit "C" what have you to say to that ? A: That is a tool that is used by burglars in entering houses, stores and so forth.
- 30 Q: What is it called ? A: A Jimmy.

CROSS EXAMINATION BY MR. RUSSELL:

31 Q: Of course it is not called by any other name ? A: Among burglars and the police I think it is commonly known as a Jimmy.

COURT:-"Having heard the evidence, do you wish to say anything in answer to the charge ? You are not obliged to say anything unless you desire to do so; but whatever you say will be taken down in writing, and may be given in evidence agains; you at your trial. You must clearly understand that you have nothing to hope from any promise of davour, and nothing to fear from any threat, which may have been held out to you to induce you to make any admission or confession or guilt, but whatever you now say may be given in evidence against you upon your trial, notwithstanding such promise or threat."

MR. RUSSELL: I would like to suggest that no case has been made out under the Code.

COURT: Do you wish to give any evidence ? A. MR. RUSSELL: No.
COURT: Under the circumstances I think there is evidence to go
before a Jury. I order them to be committed for trial.
