Lee Chick told me that this woman wanted to see me, and I asked him what time should I go, and he said "Go Friday at 1 o'clock" and I said "I will go if there is money in it." I went into the house and saw Chow Dan and told him to get out of the house. I did not touch him. I did not ask him for money. I just went there and told him to get out. He then yelled out and a crowd of men came in and two went out for the police and four of them assaulted me. They took me by the head and waist and put me down, and I was sick. They injured my head and waist and tore my clothes. I feel the effects of it yet in my arm. I am not afraid of one or two of them, but when there is a big crowd I am afraid.
