## DEPOSITIONS OF WITNESSES.

Taken at New Westminster, Nov. 22nd, 1895.

W. H. BULLOCK - WEBSTER, upon his oath saith as follows:-I was Chief of Police in charge at the last Assize held here for the County of Westminster, when the Jury brought in their verdict in the case of the Queen vs. Go Dop and Chung Chuey; I was present during part of the time the accused was

giving evidence on behalf of the defence; Judge Bole who was presiding Judge of the Assize in that case at its conclusion directed me to take the accused into custody for committing perjury in the giving evidence as such witness; I did so and this proceeding is following out such instructions.

THOMAS

DOMINY, upon his oath saith as follows:-

I am a police officer on the City force; I remember the prosecution in the Police Court of Go Dop and Chung Chuey; I gave evidence in that prosecution; in consequence of information I received from Sing Lee on the 23rd of February I went to his house between four and five o'clock in the afternoon; I found a box that had been broken open; the box was in his room down stairs; the room was an inner room; there was a counter in the room; I did not see any table in the room; there was no jewellery or money on the counter; I did not see any jewellery or money in the house; on the 27th of February, acting On a search warrant, I searched the house, Officer Batt accompanied me; I found flevelling some jewelery and some money; the maney was under Go Dop's bed and the money was in a valise; Sing Lee said the mancy and jewellery and money was his; I did not see the accused there when I first went to the house on the 23rd of February or any other time; Sing Lee was with me on both occasions when I went to the house.

SING OLEE, upon his oath saith as follows :-

I remember the 23rd of February last; about four o'clock in the afternoon of that day I went into my house and found that to box which contained my jewellery and money had been broken open and all my jewellery and money was taken; after I found what had happened I went for the police; when I found that my money and jewellery were taken I called out and said so, and some Chinamen then came into the house, and among them was Ah Fuey; I am certain that he was there; I am certain that the accused Lee Hoy was not in the house at all; Officer Dominy came back with me; there was no table in my bedroom; I never said to anybody that it was a good job that the jewellery was not taken. Question by Accused:

3.

Did I not ask you whether you had lost the gold pieces shortly after you gave the alarm? Ans. No.

Did you not till me that you were going to get the Police? Ans. I did not.

Did not I say to you that if you are going for the Police I will go out? Ans. You did not.

JOHN JAMES CAMBRIDGE upon his oath saith as follows:-

On November 8th last I was and still am Clerk of the Peace for the County of Westminster, and on that day I acted as such during the trial of the case of the Queen vs. Go Dop and Chung Chuey in the Court of Assize and Nisi Prius for that County before His Honour Judge Bole; I produce the indictment in that case Aproduce the

book of record showing the entry of the verdict; the charge was theft in dwelling house, and the verdict was guilty; the accused was a witness for the defence; I administered the oath.

AH FUEY, upon his oath saith as follows :-

I remember the 23rd of February last; about **ex** 4 o'clock in the afternoon I was outside Sing Lee's house, in this city; I heard him say he had lost something, and I ran inside the house with some other Chinamen; I waited inside till Sing Lee and the Police came; I waited outside the bedroom; I am sure Sing Lee did not say that 'it was a good thing the jewellery was not stolen because it was of the **table** table and the counter.' There was no table in the bedroom; there was a counter, but there was no jewellery on it; there were no \$5.00 gold pieces on the counter or anywhere else visible; Lee Hoy was not in the house at all; I could have seen him if he had been there; I know he was not there; I know him well.

Accused says: I do not know this witness, and have no questions to ask him.

W. A. CUMYOW, upon his oath saith as follows :-

In interpreting the questions in cross examination to the accused, when I was asking him if he had any further questions in cross examination to put to Sing Lee he said:

"I saw the jewellery on the counter; Sing Lee told me it was a good job they didn't steal this, as it was left in my hands as collateral." Prisoner being asked if he had any questions in cross examination says "No, that is all right."

STATEMENT OF THE ACCUSED.


