3. And that we are and have been since the said day, to wit, the 1st. day of August 1866 the only members of the said partnership with the exception of *Sin Cup and Yat Chow* *Sin Cup is now represented by his brother Sing Wan, and his son Sing King* *Yat Chow is now represented by his son Chew King* *who are dead said Sin Cup died in China in 1900 and Yat Chow died in China in 1902.*

6. That the said partnership consists of thirteen shares of \$1000.00 each, and that each member of the firm is the owner of one of such shares.

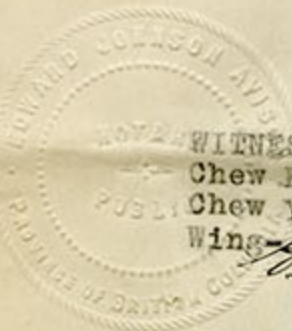
