Information and Complaint for an Indictable Offence.

The Information and complaint of Daniel B. Stevens, of Kamloops, taken this 7th day of January, 1896, before the undersigned, one of Her Majesty's S. M's in and for the sd. Co. of Yale, who saith that Ah Sam, at Kamloops, in the County aforesaid, on or about the 23rd day of December last past, one Annie Stevens, a female, unlawfully and indecently did assault, and her the said Annie Stevens did then ill-treat, and other wrongs to the said Annie Stevens did, to the great damage of the said Annie Stevens, contrary to the form of the Statute in such case made and provided.

Deposition of a Witness.

DANIEL B. STEVENS, saith on his oath as follows :---

John Kendrick, who worked for me at the time, about Dec. 23rd, 1895, informed me that he had found the accused abusing the girl Annie Stevens, my daughter, on the floor in the bakery ; she acknowledged that he indecently assaulted her, that he forced her on the floor and she tried to get up but he would not allow her to get up.

JOHN KENDRICK, sworn, saith :--

I went out of the bakery owned by D. A. Stevens, where I worked, about the 21st of December last, and went upstairs to dress; I heard an unusual noise in the bakery; I went back into the bakery and when I got into the room the accused was getting up off the floor; Annie Stevens was lying on the floor with her clothes disarranged, the lower part of her body being exposed; the accused and the girl both ran out of the room; the accused had his person ~~xxxx~~ exposed at the time and was arranging his clothing when I saw him; it was in the evening about half past four.

DANIEL B. STEVENS, being recalled, saith :--

Annie Stevens, my daughter, is about 10 years of age.

ANNIE STEVENS,, not sworn, saith as follows :---

I know the accused, he worked for my father in the kitchen; I remember 2 or 3 days before last Christmas; I had been out to the water closet; I went into the bakery; the accused was in the bakery when I came in; he threw me down on the floor and lifted up my dress and got on top of me; John Kendrick came into the room and the accused and myself ran away; the accused was holding me down on the floor.

Cross-examined by the accused :

Did you not get on my back for a ride ? A : I did; the accused carried me on his back from the dining room to the bakery; I did not fall off his back to the floor.
