1. The Claimant's name is FONG CHUN MUN, and his address for service and other purposes herein is No. 311-312, Sayward Building, Victoria, B. C., Canada.

2. The Claimant's claim is for the destruction and theft of his property and effects at Extension, B. C., when he was driven out of his place of abode by strikers in August, 1913; in respect of which said loss the Claimant claims the sum of \$154.25, full particulars whereof are hereto annexed.

3. And the Claimant further claims in respect of his said loss; for trespass; for assault on him; and for loss of employment, such damages as the Commissioner may see fit to allow.
