1864 representing *\$50.00* Fifty dollars to

WHEREAS *Ch. Hung* "a Chinaman" was this day charged
before *me*,
me of Her Majesty's Justices of the Peace in and for the said *Province*
British Columbia, on the oath of *Indran*

Indran, and others, for that
Ch. Hung residing at *Deep Creek Spillumchinn*
District of Yale, did on the *thirtieth* day of
August A.D. 1885 fraudulently pass a counterfeit
Bill of the Bank of British Columbia W.D. 1864
representing \$50.00 Fifty dollars to *Indran* *Indran*
knowing the same to be a forgery. Contrary to the

These are therefore to command you, the said Constables or Peace Officers, or any of you, to take
the said *Ch. Hung*, and him safely convey
to the Common Gaol at *Kamloops* aforesaid, and there
deliver him to the Keeper thereof, together with this Precept; And *I* do hereby
command you, the said Keeper of the said Common Gaol, to receive the said
Ch. Hung into your custody in the said Common Gaol,
and there safely to keep him until he shall be thence delivered by due course of law.

Yale, in the District or County of
